NOTICE OF PUBLIC HEARING
FOR AMBULANCE CONTRACTS FOR THE YEAR 2023**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Town Board of the Town of Nanticoke on December 13, 2022 commencing at 7:00 p.m. at Nanticoke Town Hall, 755 Cherry Valley Hill Road, Glen Aubrey, NY for the purpose of considering new ambulance contracts between (A) Maine Emergency Squad, Inc. ("MESI") and (B) Broome Volunteer Emergency Squad, Inc. ("BVESI") pursuant to which MESI and BVESI agree to furnish ambulance service within the Town of Nanticoke for the year of 2023 commencing on January 1, 2023. The total payments to be made by the Town to MESI and BVESI for the year 2023 under the Agreements shall be an amount not to exceed \$130,120.52. Those payments include: (a) a sum not to exceed \$72,020 to MESI (\$41,000 being the amount to be raised from real property taxes and \$31,020 being the estimated proceeds of MESI billing), and (b) a sum not to exceed \$58,100.52 to BVESI (\$13,000 being the amount to be raised from real property taxes and \$45,100.52 being the estimated proceeds of BVESI billing).

Copies of the proposed contracts are on file and may be examined at the office of the undersigned Town Clerk. All persons interested in the matter will be heard at the above-described public hearing. Individuals have the right to provide written and oral comments and ask questions concerning the proposed contracts or any portion thereof. NOTICE OF PUBLIC HEARING
FOR FIRE PROTECTION CONTRACTS FOR THE YEAR 2023**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Town Board of the Town of Nanticoke on December 13, 2022 commencing at 7:00 p.m. at Nanticoke Town Hall, 755 Cherry Valley Hill Road, Glen Aubrey, NY for the purpose of considering new fire protection contracts between the Town and Glen Aubrey Fire Company, Inc. (Town Fire Protection District No. 1 and Town Fire Protection District No. 2).

Said new contracts shall be upon the following general terms, to wit:

1. Glen Aubrey Fire Company, Inc. shall, at all times during the period of said contracts, be subject to call for attendance upon any fire occurring in such respective fire protection districts, and shall respond and attend upon all fire calls in said respective fire protection districts.
2. For such services, payments shall be made by the Town pursuant to said contracts for the year 2023 or as otherwise indicated as follows:
 - (A). The sum of \$77,750.00 to Glen Aubrey Fire Company, Inc. (Town Fire Protection District No. 1).
 - (B). The sum of \$60,358.00 to Glen Aubrey Fire Company, Inc. (Town Fire Protection District No. 2).
3. Each contract shall continue for a period of one year, from January 1, 2023 until December 31, 2023.
4. Each contract shall contain such other incidental terms and provisions as may be necessary or proper in connection with such contracting.

Copies of the proposed contracts are on file and may be examined at the office of the undersigned Town Clerk. All persons interested in the matter will be heard at the above-described public hearing.
