

TOWN OF NANTICOKE

A RESOLUTION APPROVING LOCAL LAW NO. 3-2021

At a meeting of the Town Board of the Town of Nanticoke, held on the 12th day of October, 2021, at Nanticoke Town Hall, 755 Cherry Valley Hill Road, Glen Aubrey, NY, the following resolution was offered and seconded:

WHEREAS, notice was given that the Town Board scheduled a public hearing for September 14, 2021 at 7:00 p.m. for Local Law No. 3 of the Year 2021 entitled "A LOCAL LAW ADOPTED PURSUANT TO CANNABIS LAW § 131 OPTING OUT OF LICENSING AND ESTABLISHING RETAIL CANNABIS DISPENSARIES AND ON-SITE CANNABIS CONSUMPTION ESTABLISHMENTS"; and

WHEREAS, notice of said public hearing was duly advertised in the official newspaper of the Town and posted on the Town Clerk's signboard; and

WHEREAS, said public hearing was duly held on the 14th day of September, 2021 at 7:00 p.m. and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and

WHEREAS, pursuant to Part 617 of the implementing regulations of the State Environmental Quality Review Act, it is determined by the Town Board that adoption of the proposed Local Law constitutes a Type I Action, pursuant 6 NYCRR 617.4(b)(2), provided, however, the Town Board does not consider the Local Law to be a "zoning" law or to create any zoning regulations. There are no other Involved Agencies and, therefore, the Town Board is Lead Agency. The Town Board has considered the possible environmental impacts of the Local Law. The adoption of said Local Law will not have a significant adverse impact on the environment and the Town Board adopts a negative declaration with respect to the Local Law; and

WHEREAS, the Town Board, after due deliberation, finds it in the best interest of the Town to adopt said Local Law.

NOW, THEREFORE BE IT RESOLVED that the Town Board of the Town of Nanticoke hereby adopts said local law as Law No. 3 of the Year 2021 entitled "A LOCAL LAW ADOPTED PURSUANT TO CANNABIS LAW § 131 OPTING OUT OF LICENSING AND ESTABLISHING RETAIL CANNABIS DISPENSARIES AND ON-SITE CANNABIS CONSUMPTION ESTABLISHMENTS"; and it is further

RESOLVED that the Town Clerk be and hereby is directed to enter said Local Law in the minutes of this meeting and give due notice of the adoption of said Local Law to the Secretary of State; and it is further

RESOLVED that the Local Law is subject to permissive referendum.
